MEMORANDUM OF ASSOCIATION

- The name of the Company is ABM KNOWLEDGEWARE LIMITED.*
- II. The Registered Office of the Company will be situated in the State of Maharashtra.
- III. The Objects for which the Company is established are :
 - (A) THE MAIN OBJECTS OF THE COMPANY TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE:
 - 1. ** To carry out software research and development work, to design, develop system software, application software and any other software in India and abroad, to start ISDLAN (Integrated Services Digital Local Network) dial for data centres, technology parks, network, internet, usernet, Cybercafe services, to establish satellite network and services related to internet, intranet and website and to act as Internet Services Provider and Consultants in the field of Web designing and development to provide E-Commerce Services and to develop customised packages for various types of customers in this field in India and abroad.
 - 2. ** To design, develop, buy, sell, import, export, represent, franchise, implement trade, hire, lease, deal with and carry on the business of computer software and information systems including packaged software, firmware, customized software, business software, educational software, entertainment software, databases, computer languages, software know-hows, software algorithms, software technologies, software projects and all other information technology products, applications and services.

- 3. ** To design, develop, configure, own, buy, sell, import, export, represent, franchise, subscribe, trade, hire, lease, maintain, deal with and carry on the business of Engineers in the field of electronics, including systems, Web, Network, Software, Hardware, System & Security, information technology education including computer courses, computer training, management courses, seminars, workshops, conferences, postal courses, education products and services on information technology, telecourses and exhibition on computers, information technology and management, Websites and Data bases.
- ** To enter into data processing data conversion, voice mail, CAD, Conversions and other such conversion related activities.
- 5. ** To design, develop, configure, own, buy, sell, import, export represent, franchise, subscribe, trade, hire, lease, maintain, deal with system integration, WAN, LAN, Computer hardware/peripherals.
- 6. To render any kind of technical, administrative, logistic assistance, including Asset Management and render all kinds of services to companies, partnerships, organisations or individuals engaged in the drilling of wells, mining, offshore, oilfiled Engineering, construction of sub marine outfalls single buoy mooring terminals, loading facilities under Waler pipelines and Oil platforms, operations of any Plant and Machinery and Vessels for mining, in any part of the world, whether for mining, in any part of the world, whether for petroleum water or any other substance.
- 7. To carry on the business of financing the industrial enterprises, companies, trust, partnerships, mutual funds, banks, institutions and other persons including individuals by way of Venture Capital, Seed Capital, Loans, Risk Capital, acquisition of Debentures, Bonds discounting or accepting Bills of exchange, Letter of Credits, promissory Note and other Negotiable Investments, to undertake factoring, forfeiting, batering, project funding and hedging.

- To act as consultants and advisors and to render services in the area of Market Survey Research; preparation of Techno-economic feasability reports, detailed project reports; providing detailed design and engineering, technical knowhow, executing turnkey assignments, conducting rehabilation studies, revival programmes, energy audits, energy conservation studies, pollution control and effluent treatments, computerisation industrial devising EDP systems; and relations, internal control systems, costing and budgetry control, management consultancy, mergers and aquistions, ledger and reminder services.
- 9. To undertake all kinds of leasing and hire purchase business relating to all kinds of machinery, plant, equipment, ships, vehicle, aircraft, rolling stock, factories, movable and immovable properties to arrange or syndicate project funding, leasing or hire purchase business and to do all types of lease structuring and lease management.
- 10. To carry on all or any of the business or investment company and to underwrite, invest in, acquire, hold, trade and otherwise deal in securities such as shares, stock, bounds, option, warrants, debentures, debentures stocks, Government Securities and other securities that may be issued by the Central, State or any other statutory bodies.
- 11. To act as authorised dealers in foreign exchange.
- B. OBJECTS INCIDENTAL OR ANCILLARY TO THE ATTAINMENT OF THE MAIN OBJECTS:
 - To acquire or purchase any running carrying on the same or similar business or businesses, as covered by the object Clause A above.
 - To purchase construct, acquire, hold, develop, sell, maintain and alter any properties such as lands, building works, orchards, houses, offices, flats and other residential & commercial, properties for business of the Company.
 - To appoint employees, consultants, agents, brokers, jobbers, and any other professionals including accountants for the business of the Company.

- 4. To provide for amusement and entertainment of all sorts to the public or in private and to own, take on lease, hire or otherwise acquire, temporarilly for a fixed period or permanentaly, open space, garden, park and other such places of amusement and to manage the same and to promote, conduct and operate exhibitions, expeditions, in connection with the business of the Company.
- 5. To set up own, purchase, take or give on lease, charter or hire or otherwise use acquire tansport vehicle, lands, buildings, flats, office, captive and all kinds, required for the attainment of the objects clause.
- To borrow or raise or secure the payment of money from any Bank or Banks or any financial institution or any other persons for the purposes of the Companys business in such manner and on such terms and with such rights, powers and privileges as the company may think fit and particularly by issue of or open bonds, shares debentures, bills of exchange, promissory notes or other obligation or securities of the company and with a view of hypothecate and/or in any way encumber or crea charge on the undertaking and all or any of the immovable and movable properties, present or future, and all or any of the uncalled capital for the time being of the Company and to purchase, redeem or pay off any such securities, subject to Section 58 A of the Act and R.B.I's. directions and to incur expenses relating thereto.
- 7. To lend, invest or deal with the money with or without interest or security, including in current or deposit account with any bank or bank, other person or persons upon such terms, conditions and manner as may from time to time be determined and u/s 58 A of the Companies Act, 1956 read with RBI.s direction to receive money on deposit or loan upon such terms and conditions as the Companies may prove, subject to the provisions of the Companies Act. Provided the Company shall not do any banking business as defined under the Banking Regulation Act. 1949.
- 8. To enter into partnership or arrangement for sharing the profits or associations of persons, joint venture with any person, persons or company and to accept

beneficiary interest in one or more private, public and charitable trust and to promote companies to carry out company's main objects.

- 9. To apply for purchase or otherwise acquire any patent, trademark, brevets, invention, licences, concessions, protections, rights, privileges and the like conferring any exclusive or non exclusive or limited rights to any secret or other information as to any invention which may seem capable of being used for any purpose of the company or may appear likely to be advantageous or useful to the company and to use, exercise, develop or grant licence, privileges in that respect or otherwise turn to account the property, right or information so acquired and to assist, encourage and spend money in making experiments, test, improvements of any invention, patent and right which the company may acquire or purpose to acquire.
- 10. To establish or support in the establishment of institutions, clubs, societies, funds, trust, conveniences calculated to benifit employees or ex-employee of the company or the dependents or the connections of such person and/or persons in any way connected with the Company whether as member, debenture holder, depositor or subject to the provisions of the Companies Act, to subscribe or grant, money for any charitable national religious, benevolent object of or the interest of its subject to section 293 A of the Companies Act, 1956 and for institutions scholarships, assistance for studies for deserving persons including those stated above.
- 11. To distribute among the members of the company in specie or otherwise any property of the company resources of the Company in the event of the winding up. Subject to the provisions of the Companies Act, 1956.
- 12. To allot shares in this Company to be considered as fully or party paid-up payment or consideration of any service or property of whatever description which the company may acquire or as bonus shares.
- 13. To amalgamate with any company or companies

having similar or differences object to the provisions of sections 391 to 394 of the Companies Act, 1956.

- 14. To open branches in India and elsewhere and to get the company registered in any foreign country and adopt such means of making known to the public the business of the Company as may seem expedient and in particular by advertising in the press., by circulars and publication of books and periodicals.
- 15. To pay out of the funds of the Company all costs, charge and expenses preliminary and incidental to the promotion, formation, establishment and registration of the company.
- 16. To provide for the welfare of employees or exemployees or (including Directors) of the company and the wives and families or the depending or connections of such person by building or contributing to the building of dwelling house or quarters to grant money pensions, gratuities allowances, bonus, profit sharing bonuses or benifits or any other payments, by creating and from time to time subscribing or contributing to provident fund, institutions, profits, sharing or other schemes, or trusts, and by providing or subscribing or contributing towards place of instruction and contributing towards place of instruction and other attendence or assistance as the Company shall think fit.
- 17. To guarantee the payment of money, unsecured or secured by or payable under or in respect of bonds, debentures, contracts, mortagages, charges, obligations and other securities of any company or of any authority Central, State, Municipal, Local or otherwise, or of any person whomsoever, whether incorported or not and generally to transact all kinds of guarantees.
- 18. To undertake, carry out, promote and sponsor rural devlopment including any programme of promoting economic welfare of or the upliftment of the public in any rural area and to incur any expenditure on any programme of rural devlopment and to assist execution and promotion thereof either directly or through an independent agency or in any other

manner and divest the ownership of any property of the company to or in favour of any public or local body or authority or State Government or any public Institution or Trust or Fund or Organisation or person as the Directors may approve and to establish and support or aid in the establishment and support of associations, Institution, Clubs, societies, funds, trust, and conveniences constituted to benifits employees or ex-employees of the company or the dependents or the connections of such persons or subject to the provisions, of Companies Act to subscribe or guarantee money for any charitable, national, religious, benevolent, general or useful object or fund, or for any purpose which may likely, directly or indirectly, further the objects of Company or the interest of its members or business.

C. OTHER OBJECTS:

- 1. To carry on business of constructional engineers, mechanical engineers, Iron Founders, Public Works and general contractors, Constructors, Builders, dealers in bridges, steel frame, Building, Steel, Iron structures of all kinds, iron and steel converters, smiths, wood workers, painters, electrical engineers and electronics and dredgers. To undertake any type of construction work comprising of Civil, Mechanical, Electrical and Electronic Works, including construction of Jetties, Brekwater, Casting of Concrete Blocks, Beams, Tetrapods, Road, Heavy Construction Works.
- To act as consulting engineers for construction of Harbour, Ports, Building, Bridges, Dams, Tunnels, etc., and to execute contracts for construction of such work. To maintain and undertake repairs of ships, Barges, Boats, Lorries, Tractors, Trailers, Crane, plant and machineries of any kind including Earthmoving machineries. To deal in or manufacture, import, export, trade or use iron and steels hardware, Cement, Lime, Stones, Bricks, sand, China Clay and any ther construction materials, Oils, Diesels, Timbers, Motors, paints, Grantie, Varnishes and other materials required for the purpose of business of the Company. To carry out the work of Harbour and port construction including dealing in blue metal, quarrying of stone and Stone Metals, Transport by means of lorries, Tippers, Tractors,

To produce, manufacture, refine, prepare, process, purchase, sell, import, export or deal in bricks. sand, Stones, marble, tiles, refactories, china, wares, sanitary materials, pipes, tubes, tubular structures cement, pains, adhesives, sheets, roofing, glass, furniture, fittings, electrical goods, water supply or storage equipment, floor polish, door closers, concrete mixers, elevators, paints, hardware, pipe fittings, lubricant oils, building materials, forest products and any other building or decorative materials made of cement, stone, clay, timber, teak, board, fibre, paper, glass, rubber, plastic, or other natural or synthetic substance or chemical.

 - (iv) To carry on business of household and office furnishers, upholsterers, interior decorators and dealers in and hirers, repairers, cleaners, storeres and warehouserers of furniture, carpets, linoleum and other floor coverings, household utensils, china and glass goods fittings, and household and office requisites of all kinds all things capable of being used therewith or in the maintaince, repair or manufacture thereof.
- 25. To carry on all types of selling and purchasing activities directly (both in internal and external market on its own or as sales, purchase agents, brokers, commission agents) to act as Service Agents for providing services after sales and other technical service; to carry on business as marketing technical consultants both in internal and external markets.
- 26.** To carry on the business as Financial Consultants, merchant Bankers, Registrar and Share Transfer Agents, Members of Dealers and Sponsors in the over the Trade Counters Stock Brokers, Portfolio Managers, Advisors, Underwriters and Managers to the sale of securities, including shares.
- 27.** To carry on the business in Debt Recovery, Credit Rating, Credit Reporting and Managements, Private placing of Securities, Swapping, Dealers in Foreign currencies & Trading, Privatisations, Securities Broking, Investment & Securities Analyst Bartering, Trust services

and Management, Futures Fund Managements, Foreign exchange, interest rate and commodity risk management services Appraisal of proposals for banks/financial institutions and other persons and Market Markets for securities.

- 28.** To promote, form or acquire and company and to take, purchases or acquire shares or interest in any company and to transfer to any such company and property of this company and to take or otherwise acquire, hold and dispose off or otherwise deal in, invest in any shares, debentures and other securities in or of any company or companies either out of its own funds or out of funds that it might borrow by issue of debentures or from Bankers or otherwise howsoever or in any other manner whatsoever and to subsidise or otherwise assist any such company.
- 29. ** To carry on business as advisers and/or consultants on matter and problems relating to the industries administration, management, organisation, accountant costing, financial, marketing, import, export, commercial or economic activities, labour statistical organisation methods, quality control and data processing, technical "know-how", operation, manufacture, production, storage, distribution, sale and purchases of goods, property and other activities of and relation to any business, trade, commercial industry, mine, agriculture, housing, or real estate and upon the means, method and procedure for the establishments, construction, development, improvement and expansion of business, trade, commerce, industry. agriculture, building, real estate, plant or machineries and all system, methods, techniques, principles in relation to the foregoing and to carry on business of rendering services on any one or more of aforesaid matters to any person, firm, company, trust, association, institution, society, body corporate, government or government department, public or local authority or any other organisation whatsoever, to act as intermediaries in the introduction of collaborators, sellers, purchasers, partners, tenants, agents, consumers, and employees.
- IV. The liability of the Members is Limited.
- V. * The Authorized Share Capital of the Company is Rs. 12,50,00,000/(Rupees Twelve Crores and Fifty Lakhs Only) divided into 2,50,00,000 (Two Crores Fifty Lakhs Only) Equity shares of Rs.5/- each with rights, privileges and conditions attached thereto as per the relevant provisions contained in that behalf in the Articles of Association of the Company and with power to increase or reduce the capital for the Company and divide the shares in the capital for the time being into several classes, and attach thereto respectively and preferential, qualified or special rights. Such rights shall not except where the terms of issue otherwise provide be alterable otherwise than pursuant to the provisions contained in the Articles of the Company.
