Analysis Of The Financial Results

ABM Knowledgeware Limited (BSE 531161) 'ABM' is one of the few Information Technology (IT) services companies operating in the niche of e-government since 1998. ABM has also forayed into Cybersecurity and Agritech. ABM announced its results on May 24, 2024, for the Quarter and year ended March 31, 2024.

Summary of Key Financial Parameters:

- 1. ABM reported Rs. 27 crores of consolidated revenue from operations for Q4 FY 2023-24, which is increased by 27% Q-o-Q. For the period reported, ABM posted consolidated Q-o-Q EBITDA, PBT & PAT (rounded figures) Rs. 9 crores, Rs.7 crore and Rs. 5 crore respectively. Revenue for 12 months ended 31st March '24 stood at Rs. 91 crore as compared to Rs. 80 Cr in the corresponding 12 months of the previous year. with a growth of 14% Y-o-Y. For the period reported, ABM posted consolidated EBITDA, PBT & PAT (rounded figures) of Rs. 24 crore, Rs.20 crore, and Rs.14 crore respectively.
- 2. ABM has achieved approx. 31% Gross Profit and 16% Net profit in the current quarter despite of very challenging situation being faced due to an increase in manpower cost, attrition. ABM's Associate Agritech company in US is still in intial stages of growth and in the investment mode. It has pulled down the profits of ABM by around Rs 62L. This trend my continue for next 1-2 years.

Performance of Subsidiary:

- ABM's Cloud-based Cybersecurity subsidiary Instasafe Technologies Private. Ltd. posted results for 12 months ended Mar-2024:
 - o Revenue Rs.12.50 crore;
 - Profit 1.08 crore;
- ABM's Agritech associate company in Silicon Valley USA, doubled the adoption of its offerings in 2023 compared to 2022. The Order booking for the first quarter of 2024 has been encouraging.

Operations of the Company:

Overall the operations of the company have been stable and uneventful.

Employee benefits expenses increased due to employees' yearly salary increments and the company's hiring of additional resources in its new initiative



of Technical Manpower Augmentation to enable the adoption of technology for the end-users.
