The voting whether by post or electronic means shall not be allowed beyond 5.00 p.m. on 25th March, 2020.

If any member casts any vote after 25th March, 2020 then that vote (by post or electronic means) will not be considered as valid vote and will be treated as if reply from such member has not been received.
